



## CJJIF Logo and Technique Use Regulations

Approved by the CJJIF Executive Committee on May 5<sup>th</sup>, 2019

### 1. Ownership and Legal Protection

The CJJIF logo and associated trademarks are the exclusive intellectual property of the Combat Ju-Jutsu International Federation.

These assets are protected under international intellectual property laws, including trademark and copyright regulations.

Unauthorized use, reproduction, or modification of the CJJIF logo or trademarks is strictly prohibited and may result in legal action.

### 2. Authorized Use

Affiliated national federations, clubs, and certified instructors are granted limited rights to use the CJJIF logo for official purposes, such as:

Promotional materials for sanctioned events

Official correspondence and documentation

Merchandise approved by the CJJIF

Any use beyond these purposes requires prior written approval from the CJJIF Executive Committee.

### 3. Design Specifications

The CJJIF logo must be used in its original form without alterations. This includes maintaining the correct colors, proportions, and design elements as specified in the CJJIF Graphic Identity Manual.

A clear space equivalent to one-eighth of the logo's height must be maintained around the logo to ensure visibility and impact.

Minimum size requirements:

Printed materials: 18mm in height

Digital use: 50 pixels in height

The CJJIF, as the sole owner of the CJJIF logo, will be the only entity authorized to make the modifications to these Regulations that are deemed necessary, as established in its statutory order. Logo as below:



#### **4. Prohibited Uses**

The CJJIF logo must not be used in any manner that implies endorsement of non-sanctioned events, products, or services.

It is forbidden to use the logo in connection with political, religious, or commercial activities not directly related to the objectives of the CJJIF.

The logo must not be incorporated into other logos or designs without explicit permission.

#### **5. CJJIF competition Rules Use and Representation**

The CJJIF Combat Ju-Jutsu Competition Rules have been developed by CJJIF specialists and are the intellectual property of the CJJIF. An integral part of these rules are the four sports disciplines of this sport:

- **Full Combat,**
- **Close Combat,**
- **Ground Combat**
- **Self-Defense.**

Copying, stealing or directly repeating the Combat Ju-Jutsu rules or individual disciplines is an illegal act contrary to international sports law and is prosecuted in commercial and civil courts. Holding competitions according to the CJJIF Combat Ju-Jutsu rules by organizations not related to the CJJIF is forgery, a type of sports fraud and may pose a threat to the safety of their participants and cannot be supported by national and international official sports bodies. CJJIF reserves the right to appeal to national and international official sports organizations in order to prevent such fraudulent activities.

#### **5. Technique Use and Representation**

Only techniques officially recognized and approved by the CJJIF Technical Committee may be demonstrated or taught under the CJJIF banner.

Demonstrations, instructional materials, and publications must accurately represent CJJIF-sanctioned techniques and adhere to the federation's standards for safety and effectiveness.

Unauthorized dissemination or modification of official techniques is prohibited.

All official techniques, methods, systems, and rules recognized by the Technical Committee of the Combat Ju-Jutsu International Federation (CJJIF) form an integral part of the Combat Ju-Jutsu discipline.

The use, reproduction, instruction, or public demonstration of Combat Ju-Jutsu techniques is strictly limited to members, instructors, and organizations officially affiliated with the CJJIF.

All techniques that originated in and derive from Combat Ju-Jutsu are the exclusive property of the CJJIF. The creation, imitation, or unauthorized use of these techniques by other individuals, clubs, or federations is strictly prohibited.

**Combat Ju-Jutsu** is a unique and historically established martial art, officially registered and internationally recognized as a sport. Any attempt to copy, replicate, or create a similar system, under a different or similar name, is considered an infringement on the intellectual and cultural property of CJJIF.

The CJJIF reserves the full legal right to pursue international legal action against any individual, organization, or entity that uses, attempts to use, or distributes Combat Ju-Jutsu techniques, names, or competition rules without explicit written authorization.

International intellectual property law

International sports law principles

Relevant national and international trademark, copyright, and federation recognition regulations.

All federations, organizations, and persons must respect the historical legacy and legal standing of Combat Ju-Jutsu as a registered and protected martial art. Violations will result in disciplinary and/or legal consequences.

## 6. Enforcement and Compliance

The CJJIF reserves the right to monitor the use of its logo and techniques to ensure compliance with these regulations.

Violations may result in disciplinary actions, including revocation of affiliation, certification, and legal proceedings.

Affiliated entities are encouraged to report any unauthorized use of the CJJIF logo or techniques to the Executive Committee.



## Annex I: Description of the CJJIF Logo

The official logo of the **Combat Ju-Jutsu International Federation (CJJIF)** is a circular emblem composed of the following elements:

### Outer Ring Text:

The phrases “**COMBAT JU-JUTSU**” (top arc) and “**INTERNATIONAL FEDERATION**” (bottom arc) are written in bold capital letters, encircling the emblem. This indicates the name and global scope of the federation.

The text is placed along a black ring outlined in gold, emphasizing strength, formality, and tradition.

### Central Acronym “CJJIF”

Positioned prominently in the center of the logo in bold yellow capital letters.

The acronym stands for **Combat Ju-Jutsu International Federation**, serving as the core identifier of the federation.

### **Intersecting rays inside a stylized geometric figure of an upward-pointing triangle:**

Located above the abbreviation, these geometric elements of the upward movement and the intersection of the force of energies form a cross - as one of the symbols of the Combat Ju-Jutsu technique, symbolize the development of knowledge and abilities, dynamic transitions in combat sports, as well as special principles of applying the techniques of Combat Ju-Jutsu.

### **Infinity Symbol or Horizontal Eight ( $\infty$ ):**

Placed below the abbreviation, the infinity symbol (eight) symbolizes the specific techniques of Combat Ju-Jutsu, the principles of their application, as well as constancy, continuous eternal learning and endless potential for improvement and discipline in the martial arts.

### **Color Scheme:**

**Gold/yellow** on a **black** background is used consistently throughout the design, conveying a sense of honor, excellence, authority, and tradition.

These colors are also visible and impactful in both print and digital formats.

### **Design Principles:**

The logo maintains perfect symmetry and circular balance, underscoring harmony, discipline, and universality — foundational principles in Combat Ju-Jutsu.

All elements are centrally aligned to ensure clarity and brand consistency across all mediums.
