NOTE:

*The order of fighting will be from light weight to heavy weight. Cadet and Junior divisions will run first, followed by adult divisions. Schedules and brackets may be modified if necessary.

3. PARTICIPATION

The nationality of competitors will be taken as indicated in their current passport or current national identification card. Competitors can only represent one country. If a competitor has dual citizenship, for instance, both National Federations must agree and confirm their agreement in accordance with current federation regulations.

Cadets and juniors are only authorized for GROUND FIGHTING divisions.

11. COMPETITION AREAS

Two competition wrestling mat areas measuring 20ftx20ft. One preparation tatami area.

12. UNIFORM CONTROL

The uniform of the championship participants must necessarily correspond to the standard approved by the rules of the competition. Athletes in uniforms that do not correspond to the standard will not be allowed to fight!

When a participant's bracket is called, he or she must be fully prepared in the next uniform, wearing either a red or blue belt as is noted on the draw sheet.

Equipment Requirements

Full gi is required for all competitors. Sleeves must be unrolled and extend to wrist bones when arms are outstretched. Pants must extend to mid shin and cannot be cut off. Gi may be of any color or brand, and a blue or red belt shall be worn for scoring purposes during competition. Sambists may wear kurtka tops with gi pants. Tight fitting rash guards are permitted to be worn under gi to prevent accidental nudity, and are compulsory for female athletes.



Gloves of adequate padding and weight are required of all competitors. Fingers shall extend at least to the first finger joint, cover the thumb, and wrap at the wrist. "Dime rolls" and weighted bag gloves are not permitted. Gloves may be any color or brand so long as they meet minimum requirements. Questions about gloves shall be settled by tournament director.



Equipment Requirements

Shin guards are compulsory for North American competitions. Shin guards may not have metal brackets or plastic plating, and shall be soft and flexible in design. Shin guards shall cover the whole shin and down to the toes on the forefoot. Shin guards must be worn UNDER gi pants.



NOTE: ALL COMPETITORS ARE *REQUIRED* TO

wear head guards. Head guards shall be of soft design and shall not include metal or plastic “face savers”. Use of karate style or olympic boxing style head guards is encouraged.



Teams must have red and blue color belts.

Groin protectors for men are mandatory, as well as mouth guards.

WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE

In consideration of being permitted to participate in any way, including travel to and from, in any tournament, practice, clinic, and related events and activities ("Activity") of NORTH AMERICAN COMBAT JU JITSU FEDERATION,

I agree: 1. I understand the nature of COMBAT JU JITSU activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of COMBAT JU JITSU. 2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability. I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate. 3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of COMBAT JU JITSU, or conditions of the premises or of any equipment used.

Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.

4. Knowing the risks involved in the sport of COMBAT JU JITSU, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death.

5. I hereby release, waive, discharge and covenant not to sue the NORTH AMERICAN COMBAT JU JITSU FEDERATION, together with their affiliated clubs, their respective administrators, directors, officers, agents, coaches, and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, legal guardians, supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees of premises used in conducting the event, all of whom are hereinafter referred to as "Releases", from any and all litigation expenses, attorney fees, loss, liability, damage or costs on account of injury, illness, disease, including permanent disability and death or damage to property, caused or alleged to be caused in whole or in part by the negligent acts or omissions of the Releases' or otherwise to the fullest extent permitted by law.
